What are the Grounds for Divorce in Alabama?

The divorce process begins with the filing of a complaint, which states the reason why the filing party (known as the plaintiff) wishes to end the marriage. If you live in Huntsville, you would file your complaint with the clerk of the Madison County Circuit Court.

If you are not citing incompatibility or the irretrievable breakdown of the marriage, you will need to present evidence that one of the following grounds for divorce has occurred:

- Voluntary abandonment for a period of one year
- Living separate and apart for a period of at least two years
- Adultery
- Domestic violence
- Being addicted to habitual drunkenness or habitual use of morphine, opium, cocaine, or another drug after the marriage
- Imprisonment for two years with a sentence of at least seven years
- Commission of a crime against nature either before or after marriage
- Hopeless and incurable insanity with confinement in a mental hospital for a period of five years
- Physical and incurable incapacitation at the time of marriage
- Pregnancy at the time of marriage, with the spouse not being the father

How Long Does the Alabama Divorce Process Take?

Each divorce presents its own unique set of facts and circumstances that can affect the amount of time it takes to resolve each issue. A relatively short marriage with modest marital property and no children will settle much more quickly than a 30-year marriage with children and sizable marital assets.

Here are some of the factors that will affect how long your divorce will take:

- If one party to the divorce is not a resident of Alabama, the filing party must be a resident of Alabama for at least six months prior to filing for divorce. (If both parties are residents of the state of Alabama, a divorce can be filed at any time.)
- Once the complaint is filed, Alabama law requires a minimum 30-day waiting period before a divorce is granted.
- If the other spouse files an answer to the complaint raising allegations of marital misconduct, the process could take significantly longer.
- The parties must try to agree to the terms of child support, child custody, visitation, the division of marital property, and alimony. Reaching such an agreement may be tedious, and a judge may order mediation if the parties cannot agree.
- Divorce can be time-consuming, emotionally exhausting, and financially draining. Appeals and modifications can take even longer.
